### 2026 Control Hours

#### Monday through Saturday Control Hours:

All controlled services (Rates 34-38) will be subject to control from June 1 to September 15 for the applicable control period within a 12 hour block between 9am-11pm. Rate 39 will be controlled every day June 1 to September 15 from 8am-11pm.

#### Sunday Control Hours:

All controlled services (Rates 34-38) will be subject to control on any given Sunday from June 1 to September 15 for any six (6) hour period between 9am-11pm.

#### Independence Day Control Hours:

All controlled services (Rates 34-38) are also subject to control on Independence Day for any six (6) hour period between 9am-11pm.

#### Load Shed:

To manage power costs and damage to the electrical system and customer equipment, load shed may start up to 20 minutes prior to the applicable control period.

All services are subject to Load Control Policy# 3230, all other District policies, and the appropriate rate schedule.

### \*\*\*\*\*IMPORTANT NOTICE\*\*\*\*\*

**NAME** changes on irrigation accounts received after April 1<sup>st</sup> will be subject to a \$150 service fee.

One (1) **RATE** change will be allowed after April 1<sup>st</sup>, but any subsequent rate change will be subject to a \$150 service fee.

If you are no longer responsible for the irrigation service(s) it is important for you to notify the office of any change in ownership and/or parties responsible for payment.

Your assistance in keeping our records up to date allows us to provide better service in the case of outages, etc. These fees are intended to help defray the cost of changes.
