SECURITY LIGHT RENTAL

AVAILABLE: To all customers.

CHARACTER OF SERVICE:

- The District will provide the yard light, install the same on Applicant's yard pole and will 1. service and replace the lamp periodically and the yard light, when necessary, without cost to the Applicant. The District will maintain service and replace lamps only during normal working hours except in case of an emergency. If such services are required during times other than normal working hours, the Applicant agrees to pay for such services.
- 2. If the Applicant desires the farmyard light installed at a location other than the District's meter pole, the Applicant shall pay for or furnish all labor and all the necessary materials required to install the farmyard light on the Applicant's pole. In most cases, if not installed on meter pole and it is on an existing pole belonging to customer, there is no charge.
- 3. In the event the Applicant desires to have a second or third farmyard light installed at other locations than the District's meter or yard pole, the Applicant's obligations to the District are the same as outlined in paragraph 2.
- Services and maintenance and replacements required and rendered by the District and which 4. are free to the Applicant shall not be covered by this agreement if such services are necessitated by acts of vandalism.
- 5. All kwh will be run through the customer's meter and billed at the applicable rate.
