## HUNTER FRISCH APPOINTED TO BOARD

Hunter is a farmer and electrician. He is owner/operator of Frisch Electric and has had the business for 28 years. He is also a third generation farmer. He farms and lives west of Madison with his wife, Sherri. They have four sons. Two sons are in the electrical business with him.

Hunter stated, "I have a lot to learn, but I am excited to get to apply my knowledge and experiences to the board and for the customers of ERPPD."

The survey will include a randomly selected group of about 100 customers to answer the survey over the phone. The phone survey should take 15- 20 minutes to complete.



We ask that you take the time to answer the questions, as your input will be used to assist the directors in strategic planning for the future.

The survey will also be available to be completed on-line. There will be a link on our website and information will be posted via Facebook. All customers are encouraged to complete the online survey.

Winners of the \$100 gift cards will be drawn at the conclusion of the survey and contacted by phone.

## RATES FOR 2019

We are excited to announce that there will be **no overall rate increase** for 2019. This is the sixth consecutive year without an overall rate increase.

As noted last year in the *Wire*, the board has approved rate studies and rate design changes to help collect the true cost of providing electricity, so that we can keep our rates cost-effective for our customers.

We will continue with our overall plan and are adding an additional 50 cent kW demand charge for a total increase of one dollar. There will also be another increase in facility charges to better **continued on page 2**

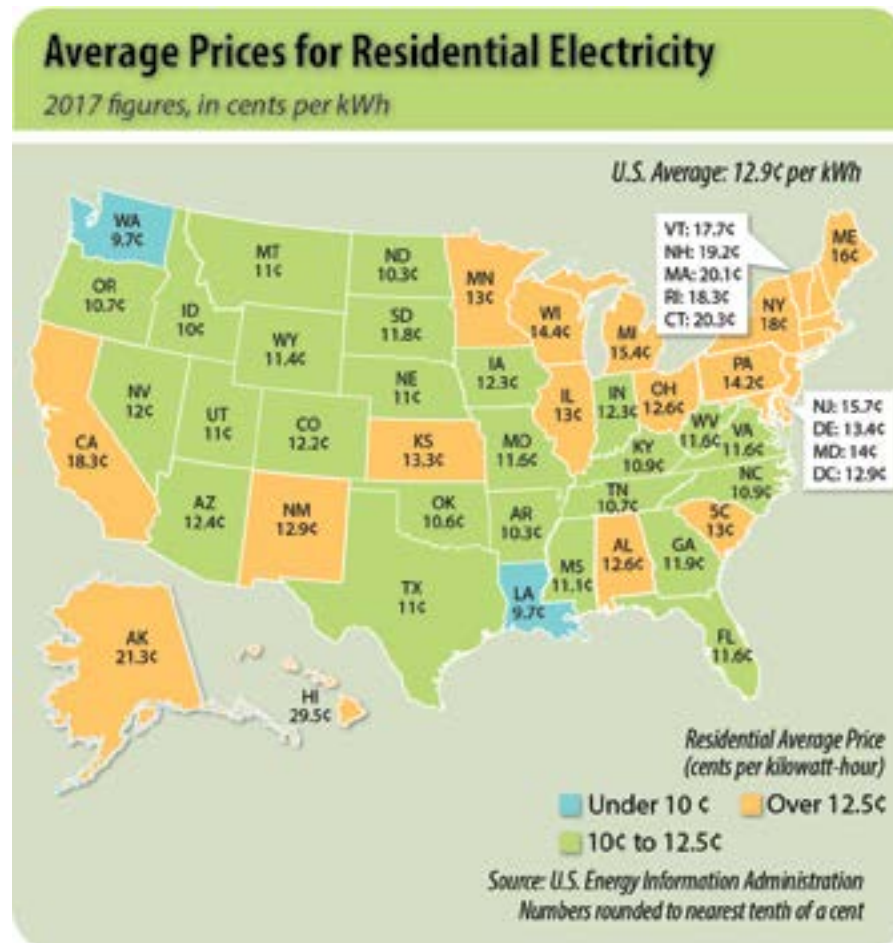
align with the cost of service.

The Energy (kWh) rate will be adjusted so that the overall changes will be revenue neutral for Elkhorn. Individual customers may see a slight increase or decrease in their bills, but most will see no change. In fact, fluctuations in the weather will probably have a greater impact on your bill.

Nebraska and Elkhorn's rates remain competitive, as can be seen to the right; a map of average residential rates from 2017, the latest data available from the Energy Information Administration (EIA). Nebraska continues to have the lowest rates compared to our neighbors. ERPPD average residential rates for 2017 were 9.8 cents/kWh.

We will continue to work hard day in and day out to fulfill our mission to provide Safe, Reliable, and Cost-effective electricity for All customers and to work with you to find innovative and efficient ways to deliver the power that you depend upon.

Three ERPPD Directors have earned the Director Gold certificate, showing their continued commitment to serve the customers to the best of their abilities.

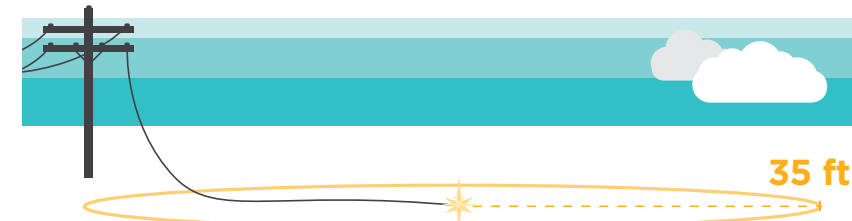

## Downed and Dangerous

If you see a downed power line, always assume it is energized and dangerous. Avoid going near it or anything in contact with the power line.



Downed power lines can energize the ground up to **35 ft.** away - so keep your distance.



Never drive over a downed line or through water that is touching the line.



Never try to move a downed power line, even if you think the line is deenergized or if you're using a non-conductive item - this will not prevent injury or death!
