Over the next couple of months, I would like to highlight that mission statement which reads: Elkhorn Rural Public Power



METER CHANGES NEARING COMPLETION

The conversion to the new Automated Metering Infrastructure (AMI) system has been in the process since March 2022.

Even with some supply chain issues, the residential meters have, largely, been installed for the new AMI system. Irrigation meter installations will restart now that load control season is over, and the remaining residential meters

will continue to be installed.

ERPPD has contracted with Border States/Chapman Metering to do the meter changes – be on the lookout for the vehicles pictured to the right.

This new AMI system updates our technology and helps to monitor the system for blinks and outages and will enhance our service to you.

ERPPD MISSION - SAFETY CON'T.

Working with electricity can be dangerous. We are committed to keeping safety front of mind to help mitigate this risk not only for our employees but also our customers and the public.

Our employees' safety starts with ensuring they receive the proper training. ERPPD's line techs go through a four-year apprentice program before becoming a certified Journeyman Line Tech. This apprenticeship is in addition to the skills and knowledge learned from a utility line program. After certification, they continue to participate in ongoing training to keep up to date on the latest procedures and advancements in technology.

Ongoing training takes place

throughout the year and is not only focused on safe work practices but also trains our employees on how to respond to potential emergencies. Staff recently participated in two examples of this emergency response training.

On August 15, we held our annual Pole Top rescue training. This annual training is provided to us through the Nebraska Rural Electric Association, Job Training and Safety program.

We held a Mock Mayday drill on July 20th. During this training, we simulated an emergency in the field and practiced how to respond to the situation. This drill was coordinated with local stakeholders including





Battle Creek Volunteer Fire and Rescue, Battle Creek Public Schools, LifeNet, and Madison County Sheriff's Dispatch Center.

Safety in the workplace is practiced by all employees. ERPPD employees hold monthly safety committee meetings where they actively discuss safety ideas and concerns. Journeyman Line Tech, Ryan Kittelson, fills our role of Safety Director and is tasked with promoting our safety



culture as well as chairing the employee-led safety committee.

Beyond training opportunities, ERRPD performs testing on our equipment. Frequent testing of our specialized equipment and personal protective equipment helps ensure safe work practices.

We also work with representatives from many organizations on various aspects of safety. This includes our participation in the Rural Electric Safety

Achievement Program (RESAP). This three-year audit process determines what areas of the program we are strong in and offers suggestions where improvements can be made. Through the RESAP program we create and follow a yearly, ongoing, safety improvement plan, that helps build a culture of safety throughout the organization.

Each of these efforts, among many more, are part of our ongoing commitment to safety. Ensuring the safety of our employees, customers, and the communities we serve, remains the first pillar of our mission statement and our top priority.
